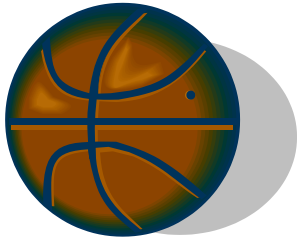

Cost and Registration

Entry fee is \$30 per team if you do not want T-shirts. If your team would like T-shirts we have an entry fee and T-shirt package which is \$60 per team. You must mark your T-shirt size on the

team registration form. I must have your entry form before the 10th of July to get the T-shirt package. All other forms will be taken until 8:30 the morning of the tournament. Proceeds will be used to continue the tournament next year.

All teams must complete an entry form



Rules

1. Teams will consist of three players and may have one substitute. Games will be played to 15 win by two or twenty win by one or a thirty minute limit whichever comes first.
2. Fouls will be called by the offense with a tournament official to settle disputes. If the official is needed his call will be final.
3. **SCORING:** One point per basket; two points make for baskets made beyond the twenty foot arc. Possession alternates after each made basket and must be taken back beyond the 15 foot line at every change of possession.
4. Each team must be registered prior to start of play and must sign in prior to start of their first game. No changes to team roster will be accepted after start of play. Each player is required to have personal identification.
5. Two divisions will be played. They will be open to all players. High school will be open to all players who are eighteen years of age and younger. Each division is limited to sixteen teams on a first come first serve basis. After these are filled, money and entry forms will be returned.
6. The above rules are general in nature; court official will brief final rules prior to start of play.
