

# Application for 4-H Harlos Grant

**APPLICATION DEADLINE:** The Boone County 4-H Harlos Grant Committee accepts applications for funding three times each year. All applications are due via email by 11:59pm on the date listed. The application period will open on the 1<sup>st</sup> day of the month.

- March 15, 2025
- June 15, 2025
- September 15, 2025

**ELIGIBILITY:** The committee accepts applications for funding based on funds availability for the following categories only.:

- For the promotion of 4-H in Boone County, Indiana.
- For the facilities at the Boone County Fairgrounds in Boone County, Indiana.
- For Educational programs and activities.

**FUNDING:** Notification of funding will take place within 45 days of application deadline. When funds are awarded, the dollar amount granted by the committee is the **MAXIMUM** amount that will be reimbursed to the club, organization, or individual. The committee reserves the right to partially fund requests. Any purchases of physical property as part of projects funded by the Boone County 4-H Harlos Grant Committee will become property of Boone County 4-H Clubs, Inc. Funds will be dispersed as follows:

1. (Preferred Method) Items for project billed to Boone County 4-H Clubs, Inc for payment OR;
2. Reimbursement to the 4-H club, organization, or individual after proof of purchase has been presented (receipts, paid orders, etc).

**CRITERIA:**

- Proposed project's overall benefit to Boone County 4-H.
- Need for the program, or project.
- Overall reach and increased awareness of Boone County 4-H (if applying for a promotion grant).
- Lasting positive impact to the fairgrounds (if applying for a facilities grant).

**REPORTING** All funded projects must be completed and the following must be returned to the 4-H Harlos Grant Committee via email within 90 days of the application deadline.

- A complete record of expenses.
- A narrative describing project implementation and results.
- Any photos/graphics from the project.

Any unused funds over \$1.00 must be returned to Boone County 4-H. Any funded project not completed within 90 days of the application deadline must reapply for allocation of funds. Re-approval of an existing project not completed within the project period is not guaranteed.
