## 2025 STEUBEN COUNTY 4-H FAIR BOUTIQUE & CRAFT SHOW RULES

1. **Booth space:** Booths are 10' x 10'. They will be marked out and assigned prior to the craft show. Please make sure that your booth does not exceed these measurements and/or impede your neighbors' booths. Should you require more space please purchase the appropriate number of spaces. Exhibitors will supply their own tent, tables and chairs. Management cannot guarantee specific sites but we will do our best to accommodate special requests.
2. **Electric Spaces:** Spaces with access to electricity are limited and will be assigned on a first-come first-served basis. Exhibitors are to supply their own extension cords. All electrical devices must be UL approved and properly grounded. Cords will be rejected and/or electrical hookup will not be allowed if code is not met. The management has the right to limit exhibitors' wattage.
3. **Set-Up/Clean-Up:** Booths may be set-up 8 AM-10 AM on the morning of the show and must be completed by 10 AM. Vendors must not begin booth clean-up until 2 PM and may not move vehicles to the craft show area until that time. Please help by tidying up your booth space upon leaving and using the trash receptacles provided.
4. **Products:** Management reserves the right to ask vendors to remove items not appropriate for sale at the 4-H Fair, including but not limited to items related to/referencing profanity, tobacco, alcohol and suggestive material. IT IS UNLAWFUL TO CONSUME OR SELL ALCOHOLIC BEVERAGES ON THE STEUBEN COUNTY 4-H FAIRGROUNDS, AND VIOLATORS WILL BE ASKED TO LEAVE.
5. **Food Items:** Vendors may sell food items that fall under the "cottage law" provided they follow all pertinent state regulations.
6. **Direct Sale Vendors:** Direct Sales are not allowed, as we are trying to encourage a space for local, handmade goods.
7. **Raffles:** Free drawings to collect additions for a mailing list are allowed provided the free prize is awarded at the end of the show.
8. **Parking:** Parking will be available on the 4-H Fairgrounds. One (1) single day parking pass per purchased space will be provided to vendors. Vehicles must be moved out of the Craft Show area by 9:30 on the morning of the show. We will block parking near the vendor area during the show to increase visibility.
9. **Payment:** Payment is due in full upon submission of this form in order to reserve your space. Booth fees are non-refundable, non-negotiable and not transferable. This event will happen rain or shine so please plan accordingly.
10. The Steuben County 4-H Fair Board and the Steuben County Park, shall not be held responsible for any injury or loss that may arise or come to the lessee, his employees or his goods or property from any cause whatsoever while said premises are being occupied under this contract on June 21, 2025, including set up times.
