First Friends club voted on officer positions and they created multiple tie blankets that they will donate to the local warming shelters.







INDIANA 4-H QUALITY LIVESTOCK CARE

Last month we hosted our first Quality Livestock Care session and we had 46 livestock exhibitors attend! If you couldn't make it, that's okay! We still have TWO more sessions available, one being this month on the 25th.







In our efforts to remain transparent and keep our 4-H families informed leading up to fair, I wanted to include a page about Animal Release at the fair.

This includes Late Entry, Early Release, Regular Release.

I have included the portion from our handbook that cover these topics.

Our Board of Directors, Barn Superintendents, and myself all want ALL Wayne County members to have the opportunity to exhibit their aniamls at fair. I encourage you to take extra time looking over the "Failure to follow the regular release policy" section.

Late Entry / Early Release

Late Entry - 4-H exhibitors who wish to make late entries because of participation in district, state, or national shows must submit request to the Wayne County 4-H Board of Directors via the Wayne County 4-H Livestock Late Entry/Early Release Form, annually. In all cases, late entry animal(s), including heifers, must be entered prior to weigh-in time scheduled for that species. Barn superintendents will be responsible for checking late entries against the submitted Wayne County 4-H Livestock Late Entry/Early Release Form.

Early Release - 4-H exhibitors who wish to request early release of entries because of participation in district, state, or national shows must submit request to the Wayne County 4-H Board of Directors via the Wayne County 4-H Livestock Late Entry/Early Release Form, annually. In all cases, early release animal(s), must check with the Barn superintendents before exiting the barn. The Barn Superintendent will be responsible for checking early release entries against the submitted Wayne County 4-H Livestock Late Entry/Early Release Form.

Regular Release of animals during fair

Animals (except dogs, cats, pets, and horses/ponies) will be released on Thursday, following the conclusion of the Supreme Showmanship Show. And then following the conclusion of the Livestock Auction on Friday.

Failure to follow the regular release policy - Any 4-H member who chooses to take his/her 4-H animal(s) off of the Wayne County Fairgrounds prior to the designated livestock release time without following the above stated rule, will incur the following penalty:

The 4-H member will not be allowed to participate in the 4-H livestock auction of the <u>current fair</u> and will not be allowed to exhibit in the project at <u>the following year's Wayne County 4-H</u> <u>Fair</u>. However, the 4-H member will be allowed to enroll in the project and complete his/her record sheet and/or educational poster/display.

The Wayne County 4-H Board of Directors, livestock project superintendents, and 4-H Extension Educators are desirous of giving every opportunity to youth to complete their project(s) and exhibit at the fair. In those instances when fair dates conflict with personal schedules and the intended exhibit is an animal, exhibitors should contact their species project superintendent to obtain information regarding possible alternative methods of exhibiting or completing the project year.









REQUIRED ANNUALLY FOR ALL REGULAR 4-H EXHIBITORS



To exhibit BEEF CATTLE, DAIRY CATTLE, SWINE, SHEEP, MEAT GOATS, DAIRY GOATS, POULTRY, and RABBITS, 4-H members must be certified through the Indiana 4-H Quality Livestock Care training OR the online Youth for the Quality Care of Animals program (YQCA).

- Members must attend ONE training session listed on this flyer OR complete the online YQCA training.
- Members must be registered on 4-HOnline BEFORE attending a session.
- Mini 4-H'ers don't need to complete QLC certification
- Those planning to be certified through the YQCA program will register at www.yqcaprogram.org and will present their completion certificate to Kendell via email.

We are looking forward to another great year of camp!


