- Hospitality Looking into options for 2024 Auction. It was discussed as we need a set up closer to the livestock pavilion.
- Nominations of the current Board as it sits, and Auction Committee Elections were held.
 Connie Brittingham motioned to approve the Amy Hein Seconded. The sitting board was elected unanimously. Nicole Kasparian will remain as President, Rachel Bult as Vice President, Julie Ziese as Treasurer, and Amanda Woodworth as Secretary.
- Commission amounts from the children's checks were discussed. It was suggested to leave the amounts the same for another year or two, to make sure our budget will allow a decrease in commission. However, Amy Hein motioned to have Zero Commissions removed from the 10 Year Livestock 4-H Members checks. Motion was seconded by Patti Nichols.
- Rule Changes- All changes were submitted to Jennifer for publication in the handbook. Except for the 10-year auction participants are commission exempt on their 10th year. That will be published in the 2025 Handbook.
- The 2024 meeting schedule was set. Auction meetings will be held immediately following the County Committee meetings in March, May, and July. If any other meetings are needed there will be a notification sent.

New Business:

- Nicole Kasparian and Julie Ziese reviewed the 2023 Budget and Income reports along with the 2024 Budget. Patti Nichols made a motion, and it was seconded by Connie Brittingham to leave the 2024 Budget the same as 2023 until we have a few years to compare with.
- Nicole Kasparian had mentioned that if there was enough time she would work on sending Holiday Cards to our 2023 Buyers only.
